

AUCTION TERMS AND CONDITIONS

PROCEDURE: The property will be offered to the public November 21st, 2023, at Oakridge Realty Auction & Co. - 2550 W. Breese Rd. Lima, OH 45806. There will be opening bidding on the property as determined by the auctioneer.

DOWN PAYMENT: 10% down payment on the day of auction. The down payment must be by personal check, corporate check, or cashier's check. **BIDDING IS NOT CONDITIONAL UPON FINANCING.** You must have your financing arranged and be capable of paying cash at closing.

ACCEPTANCE OF BIDS: Any and all successful bidders will be required to enter into a purchase agreement with the seller (Guardian) immediately following the sale, on site. All final bids are subject to the seller's (Guardian's) acceptance, or rejection. MINIMUM BID \$65,000.
